**Step 4:** Make sure you have a **CRIMINAL RECORD SEARCH REPORT** no more than **90 days old** ready to fax or scan and attach.

**Step 5: SUBMISSION!** Print your completed Information Form. You have options for submission. Either FAX or SCAN. Please do not do both.

## **WHAT HAPPENS NEXT?**
